Namozov, based on his submitted request, to the position of Advisor to the CEO as of July 15, 2024, and to terminate his employment contract by mutual agreement as of August 15, 2024.

In addition, at the meeting, it was proposed to appoint Lasis Janis, Advisor to the CEO of "Ipoteka-bank" JSCB, as the CEO of "Imkon-Sug'urta" JSC.

Having discussed the agenda item,

The Management Board decides:

1. To accept the information provided by U. Babaxanov, a member of the Supervisory Board of "Imkon-Sug'urta" JSC, on the agenda item.

2. Considering A. Namozov's request dated July 15, 2024, to terminate his powers as CEO of "Imkon-Sug'urta" JSC as of July 15, 2024, and to terminate his employment contract by mutual agreement as of August 15, 2024.

3. To appoint Lasis Janis, Advisor to the CEO of "Ipoteka-bank" JSCB, as the Acting CEO of "Imkon-Sug'urta" JSC as of July 17, 2024.

4. To ensure the transfer and acceptance of documents, inventories, and assets between A.Namozov and Lasis Janis.

5. To submit the relevant documents to the authorized state body for approval of the compliance of the candidacy of Lasis Janis with the qualification requirements for the head of the insurance company.

6. The Deputy CEO of the 'Imkon-Sug'urta' JSC, D.Toxtayev shall be responsible for the implementation of this decision, and the Chairman of the Supervisory Board of 'Imkon-Sug'urta' JSC, Z.Molnar, shall be responsible for the supervision thereof.

7. To determine that this decision of the Management Board is simultaneously the decision of the sole shareholder of "Imkon-Sug'urta" JSC.

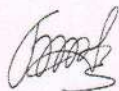
